Invitation to Bid for CONSTRUCTION OF TREATMENT AND REHABILITATION CENTER

1. The Provincial Government of Sultan Kudarat (PGSK), through the Dangerous Drugs Board Fund intends to apply the sum of Four Million Nine Hundred Fifty Four Thousand Seven Hundred Thirty Six Pesos and 19/100 (**P 4,954,736.19**) being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Treatment and Rehabilitation Center, District 1, Isulan, Sultan Kudarat**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Sultan Kudarat now invites bids for the above Procurement Project. Completion of the Works is required *within 150 calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from PGSK Bids and Award Committee Office and inspect the Bidding Documents at the address given below from *8:00 am to 5 pm*, Mondays-Fridays.
5. A complete set of Bidding Documents may be acquired by interested bidders on September 5, 2022 from given address below and *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB*, in the amount of P 4,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person.
6. The Provincial Government of Sultan Kudarat will hold a Pre-Bid Conference¹ on *September 13, 2022, 2pm* at BAC Office, Provincial Capitol Bldg., Kalawag II, Isulan, Sultan Kudarat which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 12 noon, September 27, 2022. Late bids shall not be accepted.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on 2:00 pm, September 27, 2022 at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Provincial Government of Sultan Kudarat reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
